POLICIES AND PROCEDURES

Permits/Licensing

Vendors are responsible for all licensing and permits required by law to sell or promote their product. Food Vendors are additionally required to have a Food Handlers permit. A copy of these permits must be submitted prior to participation.

Etiquette policy

- No items are to be left on the lawn overnight with the exception of shade structures and tables that are set up. To prevent harming the lawn, items left that are not up on a table may be removed. **Any items left on the grass may be confiscated.**
- The lawn will be watered at least once during the Fall Festival season. You will be given a week's notice before watering and are responsible for taking down your booth before the watering date.
- Children under 15 years must be supervised by an adult. Keep your children with you at all times.
- Alcohol distribution and consumption by vendors is prohibited. Vendors that show signs of intoxication will be asked to leave the grounds.

Food Vendors

All food vendors must first be approved by Lisa at (775) 867-3750 or farmer@lattinfarms.com before applying. We are not accepting any vendors selling baked goods, freeze dried items, pulled pork, and hotdogs. **A fee of 10% of gross sales will be levied against all food vendors each week.**

Placement & Hours

For safety reasons, vehicles not used for selling must be removed from the lawn before Lattin Farms opens each day. Permission is required to arrive late or depart early. No vehicles will be allowed to drive on the grass between 10am and 6pm, so plan accordingly.

Sanitation

Areas surrounding your booths must be kept clean at all times. **Vendors are responsible for taking their trash with them at the end of each day. Lattin Farms will provide trash cans for customer use only.**

Indemnification and Assumption of Risk

Lattin Farms is not responsible for any bodily injury, theft, or damage of property, to either the buyer or seller, arising out of or pertaining to preparation for or participation in Lattin Farms' Fall Festival. Seller further agrees to indemnify and hold Lattin Farms harmless of any claims for such injury, theft, or damage. Vendor is responsible for all remittance of licenses, taxes, and fees to operate a booth.

Impossibility

Lattin Farms reserves the right to terminate this contract if we think that there has been a misjudgement or misrepresentation of the type of booking. If the group's intentions are deemed to be controversial or inappropriate in any way, Lattin Farms reserves the right to terminate that vendor's participation in the Festival.
